2019

James River

In 2019, JRA achieved a number of "high water marks."

Our education program introduced more than 11,000 students to the James River – **the most ever** – through programs in Lynchburg, Richmond, the James River Ecology School, and Williamsburg.

In the spring, our growing watershed restoration team planted more than 29,000 trees on 36 acres of streambanks.

Our James Riverkeeper and advocacy program helped to secure record levels of funding in the state budget for agriculture and stormwater practices to address polluted runoff, and to negotiate a legislative deadline for fixing Richmond's combined sewer overflow system.

Finally, we had the great honor of accepting the Thiess International River*prize* for the collective progress we have made in restoring the health of the James River over the past four decades.

Thanks to the generous support from our donors and volunteers, 2019 was an exceptional year. Although we face greater challenges in 2020, we look forward to building on this success in order to achieve our vision of a fully healthy James River that supports thriving communities.

2019 AWARENESS

JRA issues 2019 State of the James report which shows that the river's health remained steady at a B- grade despite record rains in 2018. Over the past 40+ years, JRA has steadily helped to improve the grade of the James from a D- to a B-, with the goal to achieve a grade A James by 2026.

JRA launches new "Be A James Changer" awareness campaign, designed to inspire those who love the James to embrace their role in protecting the James through supporting JRA.

2019 ACTION

JRA launches the James River Riparian Buffer Consortium with a vision to align partners around restoring streamside buffers by leveraging resources and coordinating efforts.

WITH THE HELP OF 277 VOLUNTEERS, JRA PLANTS 7,358 TREES AND SHRUBS, TRANSFORMING 36 ACRES OF RIPARIAN BUFFERS.

JRA establishes a Living Shoreline Collaborative to scale up implementation of resilient shoreline practices along shorelines of the tidal James River.

In partnership with Richmond Public Libraries, JRA kicks off an initiative to incorporate green infrastructure and community education at city libraries to reduce stormwater pollution.

JRA installs green infrastructure projects in urban communities with 458 volunteers and 447 River Hero Homes.

Five new public river access points are opened to increase opportunities for communities to enjoy the James River and its tributaries.









JRA provides environmental education experiences to 11,260 students across the watershed.



JRA engages more than 1,000 individuals through Connect with the James paddle and boat trips, James River RX ecotherapy sessions, and James River Adventures outfitter trips.



JRA EXPANDS THE JAMES RIVER LEADERSHIP ACADEMY TO INCLUDE COHORTS OF STUDENTS IN RICHMOND, LYNCHBURG, AND WILLIAMSBURG.

2019 ADVOCACY

JRA launches an enhanced version of the James River Watch website to inform the public about bacteria levels at 25 locations across the James from Memorial Day through Labor Day.






JRA lauches new RiverReps volunteer program to train citizen advocates on how to effectively share JRA's policy objectives with decision makers through selfdirected advocacy actions.

JRA's RiverRat volunteers complete 148 river patrols covering more than 750 miles of the James and its tributaries.

JRA successfully advocates for the single largest oneyear investment in Virginia's Agricultural Cost-Share Program at \$84 million.

JRA and partners help the City of Richmond join the international Biophillic Cities Network. AFTER A 7 YEAR EFFORT, JRA SECURES SCIENCE-BASED CHLOROPHYLL A WATER QUALITY CRITERIA THAT, IF MET, WILL PROTECT THE JAMES RIVER FROM AN OVERABUNDANCE OF ALGAE THAT THREATEN ECOLOGICAL AND HUMAN HEALTH.
